SECTION 6. Accidental release measures.

6.1. Personal precautions, protective equipment and emergency procedures.

8.2. Exposure controls.

SECTION 10. Stability and reactivity.

10.1. Reactivity.

There are no particular risks of reaction with other substances in normal conditions of use.

BUTANONE: reacts with light metals like aluminium, and with strong oxidising agents; attacks various types of plastic. Decomposes under the effect of heat.

N-BUTYL ACETATE: decomposes readily with water, especially when warm.

10.2. Chemical stability.

The product is stable in normal conditions of use and storage.

10.3. Possibility of hazardous reactions.

The vapours may also form explosive mixtures with the air.
